

Regular Town Board Meeting

April 10, 2024 Kildare Town Hall

Present: Chairman Dennis Franek, Supervisors Ken Rogge, Brian D. Hawkins, Clerk Jennifer Masch and Treasurer Michelle Senzig. Residents/property owners: Don Pahl, Jason Masch, Anthony and Beth Onofrio and Tim Koscal

The Regular Town Board Meeting was called to order by Chairman Dennis Franek at 7:23 p.m.

Written Minutes of the March 2024 Town Board Meetings were provided. Motion by B.D. Hawkins to approve the minutes; second by D. Franek; carried by a voice vote of 3 ayes.

Treasurer's Report was given by M. Senzig: End of March 2024 checking account balance was \$100,056.62. Bank of Mauston CD balance was \$100,000.00. A Motion by D. Franek to enter the treasurer's report into the official minutes; second by K. Rogge; carried by a voice vote of 3 ayes.

Clerk's Report. J. Masch Reported that the April 2, 2024, election went well. If anyone is interested in working the poles, please contact the clerk. The pay for poll workers is \$15 per hour. The printer in the office is getting wore out so we are looking at upgrading, the cost for this will be around \$500 plus toners.

Ambulance Report B.D. Hawkins reported that they are looking to staff three more EMT to ensure fully staffed after one resigned. Two are working on paramedic certifications. The new ambulance is in service, and the old one will be stored at the Necedah location to be a backup when needed. The Call numbers for January were 215 total with 15 in Kildare and 24 transfers. Almost everyone has paid their dues and the balance at the end of Feb was \$671,487.10.

Supervisor's Report. D. Franek reported that patching on the roads will start next month. If needed 50lbs of asphalt can be purchased at Menards or Home Depot for \$7-\$8 until we can get a load. If purchased receipts would need to be turned in.

Public Comments Tim Koscal asked how much it costs for a hard seal on the roads. D. Franek stated that last year it was 20k per mile. They will be reviewing roads this next month.

With the review of Abandon/Unsafe structures that need to be removed, we found that the two structures at N3527 & N3543 Cty Rd HH, one that had a vehicle drive into it and the one next door to the North and one property with two structures on W3533 55th Street (Holiday Trail) that will need to get letters to have the structures removed.
