ORDINANCE NO. 8(B)**

AN ORDINANCE REPEALING ORDINANCE NO. 8(A) PROHIBITING THE USE OF  
HOLDING TANKS IN THE TOWN OF KILDARE, JUNEAU COUNTY, WISCONSIN

The Town Board of the Town of Kildare, Juneau County, Wisconsin, in Order to promote the public health, safety, general welfare and good order in the Town of Kildare and for its inhabitants, pursuant to powers inherent to it as a Town and granted to it by the electors of the Town under Section 60.10 and Section 60.22(3) of the Wisconsin Statutes, does ordain as follows:

**WHEREAS** the Town Board repeals in its entirety ordinance no. 8(a) Prohibiting the use of Holding Tanks in the town of Kildare, Juneau County, Wisconsin:

**Section 1 — Purpose**

~~Whereas the Town Board believes it is in the best public interests of the public to prohibit the use of holding tanks for private sewage systems in the Town of Kildare, the installation and use of all holding tanks for new construction is prohibited in the Town of Kildare except by appeal procedure provided herein.~~

**Section 2 — Authority**

~~This ordinance is enacted pursuant to Chapter 145 of Wisconsin Statutes and COMM Chapters 81 through 84 of the Wisconsin Administrative Code.~~

**Section 3 — Definitions**

~~The definitions contained in Section 145.01 of the Wisconsin Statutes and Section 63.02 of the Wisconsin Administrative Code are hereby adopted and made a part of this ordinance by reference.~~

**Section 4 — Appeal Rights**

~~Any person may appeal to the Town Board for a variance to the prohibition to installation and use of holding tanks in the Town of Kildare. The appeal shall be in writing, stating sufficient reasons and cause for the issuance of a variance by details as to installation plan and consent to signing a holding tank agreement.~~

**Section 5 — Appeal Hearing**

~~The Town Board shall hear the request for a variance at a regular meeting of the Town Board after giving written notice to the applicant at least seven (7) calendar days prior to the meeting.~~

**Section 6 — Appeal Decision**

~~The Town Board may grant a variance for the installation and use of a holding tank within the Town of Kildare if the Town Board finds that:~~

- ~~1. The issuance of a variance will not harm public interests or good;~~
- ~~2. There exists no other reasonable alternative;~~
- ~~3. The appeal information is complete, including necessary installation plans;~~
- ~~4. The applicant consents to the signing of a holding tank agreement;~~
- ~~5. No other reasons exist to deny the issuance of a variance.~~

~~Section 7—Fee~~

~~The applicant seeking a variance shall file with the Town Clerk a nonrefundable \$25.00 filing fee with an appeal request.~~

~~Section 8—Holding Tank Agreement~~

~~The Town Board shall require the applicant granted a variance to consent to a holding tank agreement and comply with all state laws and code requirements.~~

~~Section 9—Penalties~~

~~In addition to the other procedures contained herein, any person or persons violating this ordinance by installing or using a holding tank without issuance of a proper permit shall, upon conviction, forfeit not less than \$10.00 and not more than \$200.00 together with all costs incurred by the Town as a result of the violation including reasonable attorney’s fees. Upon failure to pay said forfeiture and costs, the person shall be confined in the Juneau County Jail until said forfeiture and costs are paid, not to exceed thirty (30) days. Each day that a violation continues to exist shall constitute a separate offense.~~

~~Section 10—Injunctive Relief~~

~~The Town Board may authorize the commencement of appropriate legal action or proceedings to prohibit the owner, residence, agent or occupant of the premises from use of a holding tank installed or used in violation of this ordinance.~~

**This code of ordinance**, from and after its effective date, shall contain all of the provisions of a general nature pertaining to the subjects herein enumerated and embraced. All prior ordinances pertaining to the subjects treated by this code shall be deemed repealed from and after the effective date of this code of ordinance.
